I WILL NOT use the requested government records for a commercial purpose.

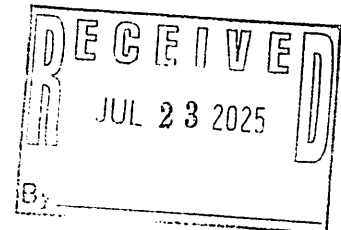
