On March 3, 2023, at approximately 7:25 pm, this writer (Ptl. McCurdy) responded to 1111 Boulevard Apartment B for a possible theft of jewelry. Upon arrival, I was met by a male identified as Charles Emerson. Mr. Emerson stated that he had an issue with his ex-wife (Melissa Fair) having a new boyfriend. While speaking with Mr. Emerson, I noticed that he was sweating profusely and extremely hyperactive. Due to this writer's training and experience, it appeared that Mr. Emerson was under the influence of narcotics. Mr. Emerson then advised me that he had taken Xanax and another narcotic for his broken toe. This writer then requested First Aid to respond to the residence to evaluate Mr. Emerson.

While waiting for first aid to arrive, this writer spoke with Melissa Fair. Ms. Fair stated that she was missing a hundred dollars from her bedroom and believed that Mr. Emerson took it to purchase CDS. Ms. Fair then stated that her credit cards had been fraudulently used but she did not want any further police involvement regarding that situation.

Mr. Emerson and Ms. Fair stated that they did have a verbal disagreement with no signs of injury or complaints of injury from either party. Mr. Emerson and Ms. Fair both stated that they did not want to apply for a TRO. At this time, two victim notification forms were explained, filled out, and signed by both parties indicating no further police involvement.

Mr. Emerson also received and then refused any further medical attention from Lavallette First Aid.
