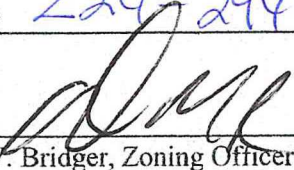

For Fences

- can be installed on the property line
- in the former borough fences can be up to 6' in height; in the former township fences can be up to 6 1/2' in height
- if the property is located on a corner lot, Police Department sign off is required

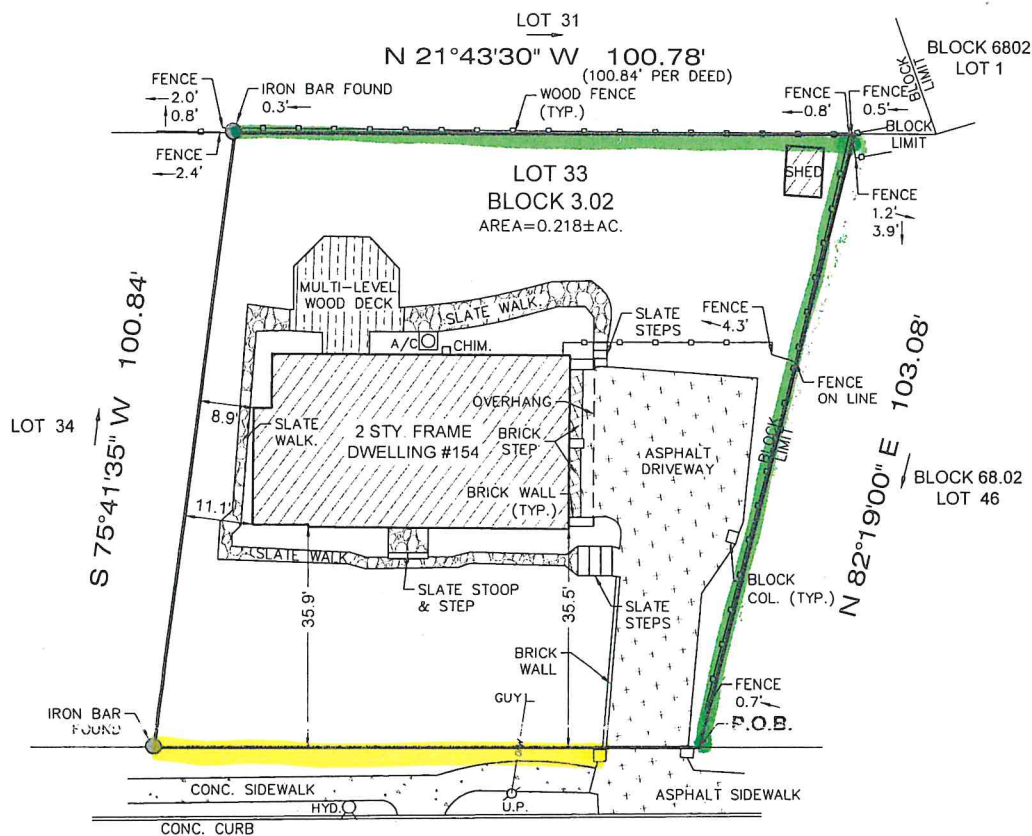
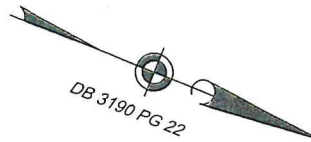
For A/C Condenser Units, Generators, Transformers, and Above-Ground Fuel Tanks

- No such device shall be located in a front yard
- On corner lots and through lots, such device may be located on the side of the property fronting on a secondary street provided it is set back a minimum distance of 10 feet from the property line along the secondary street
- Such devices shall be set back a minimum distance of three feet from the side and rear lot lines, except generators, which shall be set back a minimum distance of five feet from the side and rear lot lines

Solar Panels

- Said panels are affixed to an existing roof on an existing residential dwelling
- Said panels are affixed within the existing footprint of the existing roof
- Said panels do not increase the height of the existing roof by more than six (6) inches
- Solar panels complying with the requirements herein shall be exempt from height requirements, setback to height ratio, height to setback ratios, and required front, side and rear yard setbacks
