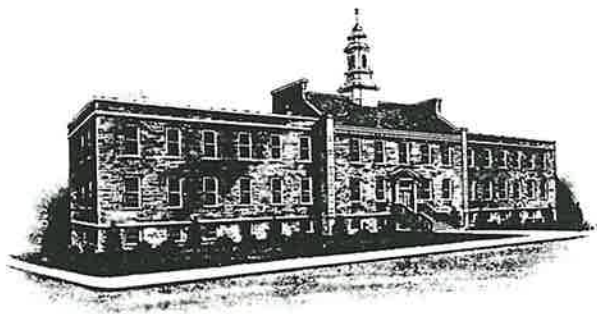

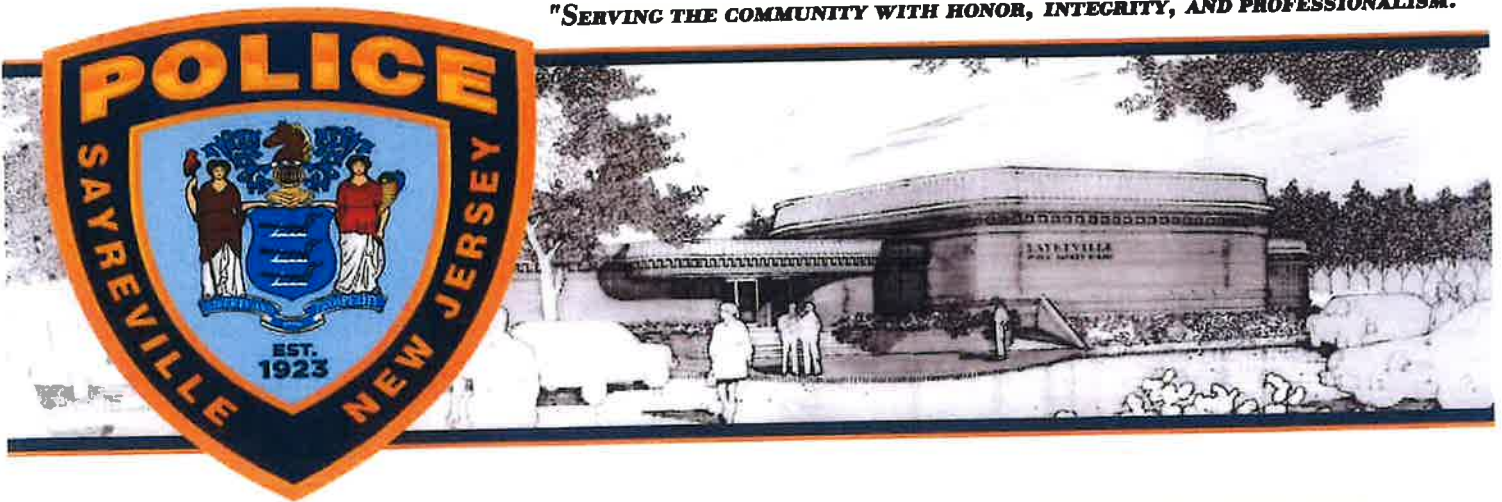

Public Synopsis of Disciplinary Action
