DRIVER'S STATEMENTS:
DRIVER 1 STATED THAT HE WAS DRIVING STRAIGHT AHEAD WHEN VEHICLE 2 CROSSED IN FRONT OF HIS VEHICLE AND THE TWO COLLIDED.
DRIVER 2 STATED THAT HE STOPPED AT THE STOP SIGNAL AND HE OBSERVED VEHICLE 1 FAR AWAY. AS HE WAS MAKING A LEFT TURN VEHICLE 1 WAS SPEEDING AND CRASHED INTO HIS VEHICLE.
OFFICER'S INVESTIGATION: VEHICLE/DRIVER 1 WAS TRAVELLING STRAIGHT AHEAD AND HAD THE RIGHT OF WAY. VEHICLE/DRIVER 2 WAS MAKING A LEFT TURN FROM A STOP SIGNAL AND FAILED TO YIELD THE RIGHT OF WAY CAUSING THE CRASH.
