Mr. Kratovil:

The Ewing Township Clerk's Office received your Open Public Records Act (OPRA) request on January 16, 2025. The official Records Custodian, Kim Macellaro, received your OPRA request on January 16, 2025. As such, the seven (7) business day deadline to respond to your request is January 28, 2025. This response to your request is being provided to you on the 7th business day after the custodian's receipt of said request.

Your OPRA requested the following:

1. Documents or other records sufficient to show the total municipal revenue collected from each cannabis business in the municipality for the calendar year 2024.

This response is being provided to you in its entirety with any necessary redactions according to N.J.S.A. 47:1A-1.1. This is being transmitted to you via email as per your request. Pursuant to N.J.S.A. 47:1A-5.b., the cost associated with this request is zero dollars.

At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
