7. If the Candidate is also the Petitioner, then the Candidate signs on the Petitioner's line and both of the Candidate's lines in the presence of a notary or someone authorized to take oaths in NJ on pages. (The Notary/Oath Taker must sign on both pages 2 & 3).
8. Petition must be filed with the Municipal Clerk on or before 4 p.m. 71st day prior to the Primary Election.
9. All candidates are required by law to comply with the provisions of "The Campaign Contributions and Expenditures Reporting Act." For further information, please call the Election Law Enforcement Commission at (609) 292-8700.
