All Petitions and Acceptances must be filed with the Officer to whom they are addressed before 4 p.m. at least sixty-four days previous to the day of the holding of the Primary Elections (NJSA 19:23-14)

The names need not be signed to the same original petition. Copies may be made to which signatures may be attached but every petition or copy thereof shall have annexed the affidavit of one or more of the signatories that the other signers have signed in good faith, for the purpose therein mentioned.

Signatures required. The number of signers of any such petition shall be at least 5% in number of the total vote cast by the voters of that political party at the last preceding primary election held for the election of that party's candidates for the General Assembly. In no case, however, shall there be fewer than one signer of any such petition.
