I am not required to fill out an official form or use a particular software platform to submit my request per NJSA 47:1A-5(f), which states that an email from a requestor including all of the information required on the adopted form shall suffice in place of a completed form as a valid government record request.

I HAVE NOT been convicted of any indictable offense under the laws of New Jersey, any other state, or the United States.

I WILL NOT use the requested government records for a commercial purpose.

I AM NOT seeking records in connection with a legal proceeding.

Records requested:

2025 police payroll records for January 1, 2025 to December 31, 2025, including the following:

1. Total annual earnings for each full-time police officer (all ranks).
2. Compensatory time earned by each full-time police officer.
3. Overtime earned by each full-time police officer.
4. Extra Duty Pay earned by each full-time police officer.
5. Shift commander duty pay for each full-time police officer to include any special pay for officers of all ranks for out of job title adjustments.
6. Any other compensation to the police officer not named above.
