Re: Objection to Nominating Petition for Sixth Ward Councilmember, City of Elizabeth – 2026 General Election- Janei Holder

Dear Ms. Rajoppi:

Please be advised that this firm represents Frank Mazza (“Mazza”), a resident of the City of Elizabeth and a candidate for the office of Councilmember for the Sixth Ward of the City of Elizabeth in the 2026 General Election.

Pursuant to N.J.S.A. 19:13-10, Mr. Mazza hereby files this formal objection to the nominating petition submitted on behalf of Janei Holder (“Holder”) for the office of Sixth Ward Councilmember for the November 2026 General Election.

As set forth in N.J.S.A. 19:13-5, a candidate seeking election to the office of ward councilmember in the City of Elizabeth must submit a nominating petition containing not less than **138** valid signatures of qualified voters. The total number of signatures submitted is 284. However, a substantial number of signatures are invalid, bringing the total number of valid signatures well below the required 138 signatures required by statute.

Specifically, the petition contains numerous signatures that are invalid and must be rejected, including but not limited to:

1. Signatures of individuals who are not registered voters or not registered voters within the ward and therefore are not qualified to sign the petition; and

2. Signatures of individuals who previously signed the nominating petition of Frank Mazza for the same office; and
3. Other issues such as incomplete addresses, lack of signature and/or name, or other deficiencies, which will be set forth below.

The basis for Mazza's objections find their support in N.J.S.A. 19:13-4 which states in relevant part:

Such petition shall set forth the names, places of residence and post-office address of the candidates for the offices to be filled, the title of the office for which each candidate is named, that the petitioners are legally qualified to vote for such candidates and pledge themselves to support and vote for the persons named in such petition and that they have not signed any other petition of nomination for the primary or for the general election of such office.

(emphasis added).

Accordingly, where an individual has signed the petition but is not registered, that individual is not legally qualified to vote, and said signature should not be counted towards the minimum signature requirement. In addition, where a signer is not a registered voter of the 6th Ward, said signer is not legally qualified to vote in that ward, and said signature should not be counted towards the minimum signature requirement. Lastly, where an individual previously signed Mr. Mazza's nominating petition, a petition for the primary election and thereafter signed the challenged petition for the same office, the subsequent signature is invalid, as the signer has falsely certified that "they have not signed any other petition of nomination for the primary or for the general election of such office."

Based upon Mazza's review of the subject petition, the following individuals are not registered voters:

The total number of signatures of non-registered voters and signatures outside the 6th ward/not registered totals 173 leaving 111 presumptively valid signatures, well below the required 138 signatures. On this basis alone, the petition should be rejected, and Holder should not be certified for placement on the 2026 General Election ballot.

There are an additional 3 signatures that must be rejected since the voter also signed the primary petition for Frank Mazza:

P1- Ln. 40	M3- Ln. 47
P3- Ln. 2	M3- Ln. 40
P3- Ln. 19	M3- Ln. 38

The total number of signatures that should not be counted for the reasons stated totals 176, leaving 108 presumptively valid signatures. Since the petition contains fewer than the 138 valid signatures required by N.J.S.A. 19:13-5, the petition is legally insufficient and must be rejected.

Accordingly, Mr. Mazza respectfully requests that the Union County Clerk:

(a) Review the petition line-by-line and determine the validity of each challenged signature;

(c) Reject all signatures that are not in compliance with N.J.S.A. 19:13-4, N.J.S.A. 19:13-5, and other applicable provisions of Title 19; and

(d) Determine that the petition fails to contain the minimum number of valid signatures required by law and therefore should not be certified for placement on the ballot for the 2026 General Election.

Mr. Mazza reserves the right to supplement this objection and provide additional evidence, voter registration records, petition comparisons, and legal argument in the event a
