A.D.A. COMMITTEE:	Three times per year; First Thursday in March, June & September at 10:00 am in the Court Room.
AFFORDABLE HOUSING BOARD:	Four times per year; Second Wednesday in January, April, July and October at 6:30 pm in the Court Room.
COMMISSION ON AGING:	Bi-monthly (every 2 months), starting in January, the second Tuesday of each month, at 9:00 a.m in the Conference Room at the Senior Center, 12 Halsey Reed Road. There are no meetings in July and August.
CULTURAL ARTS COMMISSION:	All meetings will be held in the Monroe Township Library's Activity Room at 6:30pm on the third Monday of the month. In January and February, the meetings will be on the fourth Monday due to federal holidays.
