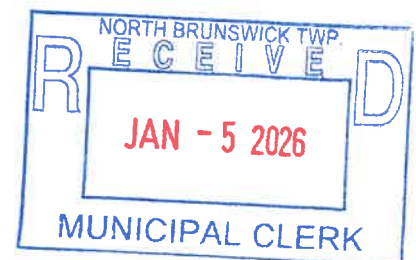
I HAVE NOT been convicted of any indictable offense under the laws of New Jersey, any other state, or the United States.
