Dear Mr. English,

We are in receipt of your OPRA request (copy attached) received April 17, 2026, wherein you have indicated that these records are to be used for "commercial purposes". Under P.L. 2024, c.16 a requestor who intends to use the record for the above purpose or intends to give the records to another person for such purpose is subject to a 14-business day deadline.

However, your request consists only of a subject line "2026 week 16 Residential Property Liens" which is considered too broad. We have marked your OPRA request as satisfied and closed. Any person who has been denied access to a government record by a records custodian of a public agency can file a complaint with the Government Records Council (GRC). N.J.S.A. 47:1A-6.
