On the above date and time, I PTL. Zilenas was in uniformed patrol utilizing my marked patrol vehicle #40. While on patrol, I was dispatched to 203 Dupont Avenue, Seaside Heights, 08751, for a Welfare check. This welfare check was in regard to Mr. John Yates making statements on "YouTube" that he was going to kill himself. It is to be noted that this is an ongoing issue with this residence and the "YouTube Stream" regarding multiple out-of-state phone calls harassing Mr. John Yates.

I responded to the call for service and arrived on location momentarily. I then greeted Mr. John Yates at the front door of the residence. It is to be noted that there were no signs of distress but annoyance in Mr. Yates's posture. Mr. Yates stated that he is not suicidal and everything is okay in his residence. Officers later left the location and cleared with reports to follow.

Later in the night, I received a phone call regarding Mr. Yates. His brother called up, advising authorities that Mr. Yates was being harassed and had a video of the stream. Officers took notes of the video and attached them to the file below. This incident was recorded and reviewed on body-worn camera #35. Reports to follow in detectives bureau.
