He sent her a picture of his wrist being cut. She said she then called the police and told him. She then said he said that the picture was an old picture and he sent them to show her why he did a while back. The two spoke and she stated that it was a misunderstanding and that is why she called back.

I then spoke with Yates. He told me that she called and did not believe that he had done harm to himself in the past. He then sent the old picture showing that he did. He said that he did not do anything to harm himself recently and did not want to. He told me that he was currently in North Carolina with family. He re affirmed that he did not want to harm himself again to me via cell phone.

It should be noted that I called him back on 12/15/2022 to make sure he was still ok. He told me that he was OK and that he was still down in NC. He stated that when he came back home he would come and see me to prove that he was ok.
