Narrative / Additional Charges and Information

01/15/2025 (Wednesday)

On the above date, while on patrol on East Avenue N/B near Piercetown Road in Fairfield Township, Cumberland County, I observed a gray in color Chevrolet Malibu traveling S/B. My stalker radar observed the vehicle traveling at a speed of 43 miles per hour. It should be noted the posted speed limit for East Avenue is 25 miles per hour. I conducted a u-turn in my Troop Car and positioned it behind the gray Chevy Malibu. I activated the overhead emergency lights in my Troop Car and conducted a motor vehicle stop in the driveway of 502 East Avenue. I approached the vehicle and identified myself and the reason for the stop to the driver. The driver stated to me that she did not have her license on her, but she provided me with the registration and

insurance for the vehicle. The driver provided me with her name and date of birth, Jessica Yates [REDACTED]/1985). A subsequent lookup of the name the driver provided yielded negative results. I was then able to locate the name and date of birth for a female matching the description of the driver in ECDR, who had been issued tickets in that vehicle before. The female in ECDR, Jonarah Salvador, also had the address 502 East Avenue in Fairfield Township, Cumberland County. I compared the driver's license photo for Jonarah and my driver and determined that Jonarah was in fact the driver of my vehicle. A search of Jonarah's driver's license revealed that her driving privileges were suspended and she had the following active warrant for her arrest;

- ATS Warrant #EJ46390 in the amount of \$1001.00 out of Elk Township.

I aksed Jonarah out of the vehicle, where she admitted to providing me with a false name, see IR #A040202500055 for further details. Jonarah was then placed under arrest and handcuffed. She was searched with negative results, secured in the rear of Troop Car 472A, and read her Constitutional Rights as per Miranda. She was then transported back to the Bridgeton Station, where she was processed accordingly. I made contact with Ofc. Messina #2243 from the Elk Township Police Department, who provided me with a new court date of 01/28/2025 at 1:00 PM. Jonarah was ROR'd on her ATS warrant and provided with her new court date and the proper paperwork. She was issued her respective MV Summonses and provided with a courtesy transport back to her residence.
