SPOKE WITH STEPHEN RUSSO WHO TOLD ME HIS NEIGHBORS AT 213 NEW JERSEY ROAD HAD A FENCE PUT UP YESTERDAY AND REMOVED HIS TREE OUTSIDE OF HIS PATIO. I OBSERVED A SMALL TREE ON THE CURBSIDE OF 211 NEW JERSEY ROAD. I SPOKE WITH THOMAS YOUNG, THE RESIDENT AT 213 NEW JERSEY ROAD, HE TOLD ME HE HIRED TWO GUYS FROM A FENCING COMPANY BUT THEY DID THIS AS A SIDE JOB. HE TOLD ME WHILE THE MALES WERE DIGGING UP THE FOUNDATION FOR THE FENCE, THE DEAD TREE ON 211 NEW JERSEY'S PROPERTY WAS DUG UP BECAUSE THE FENCING CONTRACTORS NEEDED THE SPACE. I SPOKE WITH STEPHEN AND TOLD HIM I WILL CONTACT CODE ENFORCEMENT FOR THE BOUNDARIES OF THE PROPERTIES AND TO SEE IF THEY WERE ALLOWED TO REMOVE THE TREE. STEPHEN WANTED TO SIGN CHARGES AGAINST THE TWO MALES WHO REMOVED THE TREE AND I TOLD HIM I WOULD FOLLOW UP WITH HIM AFTER I SPEAK WITH CODE ENFORCEMENT.
