RESPONDED TO 205 NEW JERSEY ROAD FOR A REPORT OF BURGLARY FROM A VEHICLE. SPOKE WITH MR. WOODWARD AND HE TOLD ME DURING THE CROSS-FILED CASE WHEN HE MOVED HIS VEHICLE, SOMEONE ENTERED HIS VEHICLE AND TOOK HIS FULTON BANK DEBIT CARD. MR. WOODWARD HASN'T SEEN HIS DEBIT CARD SINCE THE NIGHT OF THE DWELLING FIRE AT 203 NEW JERSEY ROAD AND THINKS SOMEONE WENT INTO HIS CAR BEHIND THE DPW BUILDING. HE CALLED HIS BANK TO CANCEL THE CARD AND THERE WERE ALSO NO FRAUDULENT CHARGES. I ASKED MR. WOODWARD IF HE LOST THE DEBIT CARD AND HE SAID HE DOUBLE CHECKED HIS VEHICLE AND COULD NOT LOCATE IT. I VIEWED THE SURVEILLANCE FROM THE NIGHT AND I COULD NOT SEE HIS CAR ON THE CAMERA, BUT I COULD SEE THE AREA OF WHERE IT WAS PARKED. I DID NOT SEE ANYONE IN THE AREA OF HIS CAR IN THE SURVEILLANCE FOOTAGE.
