Mr. Armetta stated that Ms. Lurig is harassing the renters by constantly calling the police on the renters. Mr. Armetta believes that Ms. Lurig is attempting to run them out of town by constantly calling the police. Mr. Armetta also stated to me that his tenants are being harassed and video taped by Ms. Lurig at night.
