AT 12:58 ON JULY 22, 2017 I (PTL. GEBLER) AND PTL. SCHULTE WERE DISPATCHED TO 32 BLAINE AVENUE IN SEASIDE HEIGHTS, NJ. WE WERE INFORMED BY DISPATCH THAT THEY RECEIVED A CALL ABOUT A GAS LEAK COMING FROM THE RESIDENCE 32 BLAINE AVENUE. UPON ARRIVAL WE SPOKE WITH A FEMALE LATER IDENTIFIED AS YVONNE THOMAS. MS. THOMAS INFORMED US THAT SHE WORKS FOR A CLEANING SERVICE THAT WORKS AT 32 BLAINE AVENUE. MS. THOMAS TOLD US THAT WHILE SHE WAS CLEANING THE HOUSE SHE NOTICED A STRONG ODOR OF GAS IN THE AREA OF THE HOUSE AND CALLED THE POLICE DEPARTMENT TO COME CHECK THE AREA.

AFTER SPEAKING WITH MS. THOMAS MYSELF AND PTL. SCHULTE ENTERED THE HOUSE IN ORDER TO LOCATE WHERE THE ODOR WAS COMING FROM. ONCE WE ENTERED THE HOUSE WE COULD NOT SMELL ANY GAS AND CONTINUED TOWARDS THE BACK OF THE HOUSE. AFTER WE EXITED THE HOUSE INTO THE BACKYARD WE WERE ABLE TO SMELL THE GAS. AS WE MOVED TOWARDS THE SIDE OF THE HOUSE THE ODOR OF GAS BEGAN TO GET STRONGER. WE LOCATED A PIPE THAT WAS DENTED AND COULD FEEL GAS COMING FROM THE PIPE DUE TO THE DAMAGE (SEE ATTACHED PHOTO).

AFTER I (PTL. GEBLER) SAW THE DAMAGE TO THE PIPE I NOTICED A VEHICLE PARKED CLOSELY TO THE PIPE. MYSELF AND PTL. SCHULTE FOUND A DENT IN THE REAR PASSENGER SIDE OF THE VEHICLE. IT WAS AT THIS TIME THAT THE FIRE DEPARTMENT SHUT THE GAS OFF TO THE HOUSE TO ELIMINATE THE GAS LEAK FROM 32 BLAINE AVENUE. WE INFORMED MS. THOMAS THAT IT APPEARED SHE BACKED HER CAR INTO THE PIPE CAUSING THE LEAK.

THE FIRE DEPARTMENT SHUT THE GAS OFF AND NOTIFIED NEW JERSEY NATURAL GAS OF THE INCIDENT THAT OCCURRED AT 32 BLAINE AVENUE. THE SEASIDE HEIGHTS FIRE DEPARTMENT CHIEF (KEN ROBERTS) STAYED AT THE SCENE TO WAIT FOR NEW JERSEY NATURAL GAS TO COME OUT AND FIX THE BROKEN PIPE ON THE HOUSE.

AT THIS TIME, ALL PARTIES INVOLVED DID NOT WISH A MOTOR VEHICLE ACCIDENT REPORT.

THERE WAS NO FURTHER INCIDENT.
