



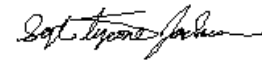

78. Narrative On the above date and time while in uniformed patrol in vehicle 917 I responded to the area of South St and Miller Rd for the report of a suspicious male that was standing in the road. The caller, Timothy Dougherty, advised that he was driving on South St attempting to make a turn onto Miller Rd when he noticed a male - later identified as Nick Rastetter, in the road. Dougherty briefly spoke with the subject advising him to get out of the road so he does not get hit by a vehicle. This individual and Dougherty exchanged words and Dougherty advised that the individual told him to get the fuck out of here before he left the area. The male was described as a black male about 5'10", with a beard wearing a wind breaker and he was last seen heading towards the Green on South St. As I responded to South St I observed a male fitting that description and stepped out to speak with him and identified him as Nick Rastetter from East Orange NJ. Rastetter advised that he had been staying in a shelter due to housing issues in East Orange. When asked about the incident Rastetter advised that he spoke with Dougherty when he advised him not to stand in the street. At that time Rastetter told Dougherty he wasn't in the street and that Dougherty was welcome to make the turn. Rastetter advised that Dougherty kept talking at which time he believed that Dougherty was being disrespectful in the way he was addressing Rastetter. Rastetter then advised he told Dougherty "you can shut the fuck up and go about your business" and then left the area. During the investigation Dougherty approached patrols and began conversing with Rastetter about the incident. They exchanged words for a short period of time and Dougherty went on his way. County Dispatch cleared Rastetter of any warrants and he left the area without incident. No further action taken at this time.
