In reference to the attached OPRA request, this is a similar request from the first one. I will use the first request since it is much more detailed.

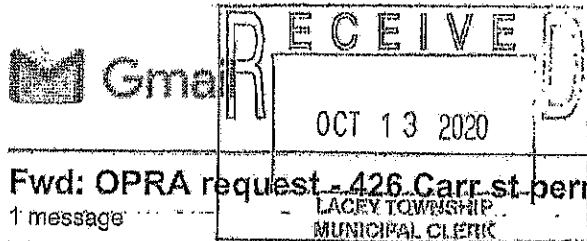

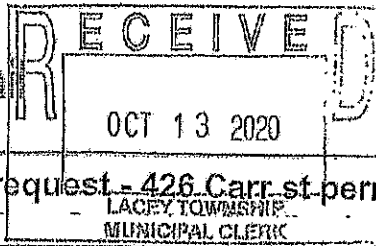
