We normally just appear and then adjourn.

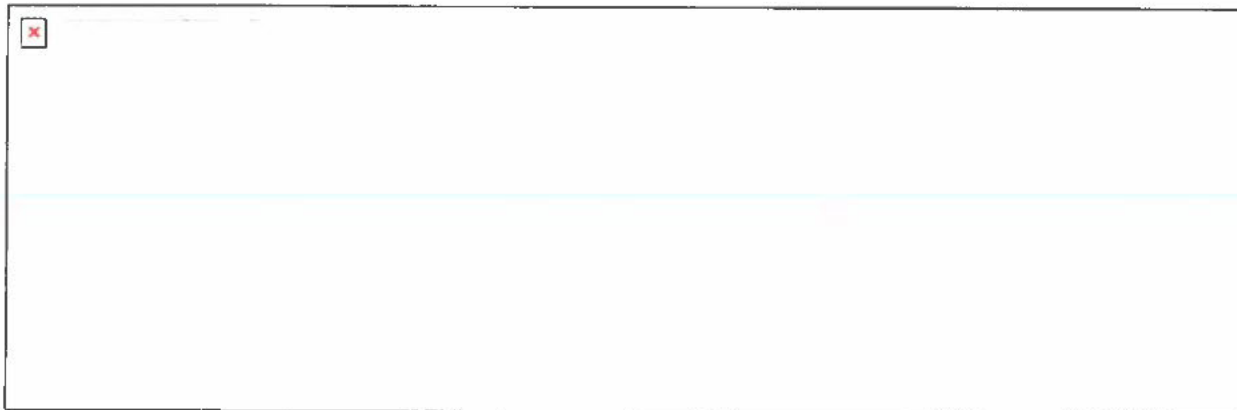

Respectfully, your office opening a file has no legal effect, and does not change the fact that there is no pending indictment against Mr. Hone. Thus, there is no legal basis for sending out a subpoena issued in the name of the Court for the purpose of compelling documents for a trial that does not exist. Post-Conviction discovery is only available after a showing of good cause with the court, and it defies logic that even though you're not entitled to discovery, you are attempting to seek records belonging to a crime victim via legal process. Please advise if you will withdraw all subpoenas, or if a motion to quash will be necessary.

Good Morning Mr. Lane,

This morning I spoke with the victim in Mr. Hone's matter, who informed me that defendant keeps stating in family court filings that he is using your office to subpoena a bunch of the victim's records, including records related to her cell phone and other private matters. I would once again like to assert that it is our office's position that all such subpoenas are in violation of court rules, as there is no active indictment with Mr. Hone in Monmouth County. Additionally, Mr. Hone has been determined to be a vexatious litigant, and is not permitted to make filings directly with the Court without permission from the assignment judge in Ocean County. It is important that he is not able to use your office to get around the Court's order. Please advise if there are any outstanding subpoenas related to the victim's personal records, so that our office may file a motion to quash.
