Good day,

The Ocean County Sheriff's Office received your Open Public Records Act (OPRA) request on or about July 24, 2025. The official Records Custodian, Michael J. Zolezi, received your OPRA request on July 24, 2025.

The following records were requested:

- "On 7/18/25 between the hours of 6:30pm and 8pm a 911 phone call was received for EMS at the Holiday City Clubhouse located at 1846 Yorktowne Blvd. I believe there was more than one call made to 911 on the same incident at different times. I would like these phone call (s). Thank you."

The following is a line-by-line response to your requested items.

A. Requested records

1. 9-1-1 call(s) related to a first-aid call to the Holiday City (Silverton) Club House on July 18, 2025. **9-1-1 call audio and Computer Aided Dispatch (CAD) reports are attached to the email. Redactions have been made per New Jersey Law to protect Personal Identifying Information (PII).**

OPRA: RIGHT OF APPEAL

If your request for access to a government record has been denied or unfilled within the seven (7) or fourteen (14) business days required by law, you have a right to challenge the decision by the responding agency to deny access. At your option, you may either: 1) institute a proceeding in the Superior Court of New Jersey; or 2) file a complaint with the Government Records Council ("GRC") by completing the Denial of Access Complaint Form. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County. Questions regarding the GRC's Denial of Access Complaint process can be directed to the GRC toll-free telephone at 866-850-0511, by mail at PO Box 819, Trenton, NJ, 08625, by e-mail at Government.Records@dca.nj.gov, or at their web site at www.state.nj.us/grc. The Council can answer general inquiries about OPRA.

The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
