Good day,

The Ocean County Sheriff's Office received your Open Public Records Act (OPRA) request on or about March 20, 2025. The official Records Custodian, Michael J. Zolezi, received your OPRA request on March 20, 2025.

The following records were requested:

- "911 call log from December 31st, 2023 responding to the address 228 Hancock Ave, Seaside Heights, New Jersey 08751. If possible no audio, just a log of what was said."

The following is a line-by-line response to your requested items.

A. Requested records

1. 9-1-1 Call Log and Computer Aided Dispatch (CAD) report for the above date and location. **See attached report. Redactions were made to protect Health Insurance Portability and Accountability Act (HIPAA) information.**

OPRA: RIGHT OF APPEAL

If your request for access to a government record has been denied or unfilled within the seven (7) or fourteen (14) business days required by law, you have a right to challenge the decision by the responding agency to deny access. At your option, you may either: 1) institute a proceeding in the Superior Court of New Jersey; or 2) file a complaint with the Government Records Council ("GRC") by completing the Denial of Access Complaint Form. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County. Questions regarding the GRC's Denial of Access Complaint process can be directed to the GRC toll-free telephone at 866-850-0511, by mail at PO Box 819, Trenton, NJ, 08625, by e-mail at

Government.Records@dca.nj.gov, or at their web site at www.state.nj.us/grc. The Council can answer general inquiries about OPRA.
