Good day J.D.,

The Ocean County Sheriff's Office received your Open Public Records Act (OPRA) request on or about March 4, 2022. The official Records Custodian, Lt. Adrian Bullock, received your OPRA request on March 8, 2022.

You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc.

The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
