Upon arrival we made contact with Carolyn who stated the caller, Joshua, was [REDACTED] and that this was a group home. Carolyn also stated that Joshua was at Chilton Medical Center the day before for the same reason. Officers spoke to Joshua who stated he had [REDACTED] and needed to go to the hospital. Carolyn stated that she contacted the parents who stated they did not want Joshua to go because they had power of attorney. Joshuas parents advised they would take him to the hospital tomorrow. The parents explained to Joshua on the phone that he should try to go to sleep tonight and they would bring him to a doctor tomorrow. When we initially left the house, dispatch advised officers that there was another call from the residence and Joshua began breaking things. Officers arrived back on scene, and Joshua advised he needed to go to the hospital again. SGT Franciose and PO Powers arrived on scene and assisted officers in talking with Joshua. SGT Franciose spoke with the parents and they advised they would release him to go to the hospital. BLS Wayne First Aid 972 arrived on scene and transported Joshua to Chilton with PO Powers following. The group home, Attain and Gain, stated a new shift was coming on at 11PM and when they arrived they would send someone to Chilton.

Joshua's mother stated that she did not want Joshua to go to a hospital. She requested that Joshua remains at the group home or the staff transports him to her residence. We were informed that staff would be transporting Joshua to his mother's residence. We identified ourselves and informed the involved parties of our body worn cameras upon initial contact. We cleared from the scene. Nothing further to report.
