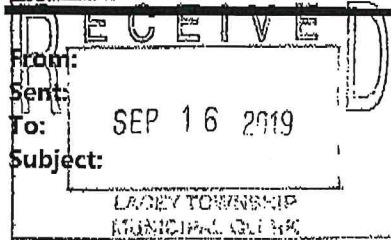

SUBJECT: OPRA Request – MVA – Eleazar Cholula-Garcia

On Monday, September 16, 2019, this agency received the attached Open Public Records Act Request for a copy of all motor vehicle summons and the accident report involving Eleazar Cholula-Garcia that occurred on September 14, 2019.

The police record currently on file is considered an “**Criminal investigatory records**” records which are not required by law to be made, maintained or kept on file that are held by a law enforcement agency which pertain to any criminal investigation or related civil enforcement proceeding. (“**Denied**” under N.J.S.A. 47:1A-1.1 [4])

It is also an “**Ongoing investigation**” any records pertaining to an investigation in progress by any public agency shall be denied if disclosure of such record or records shall be detrimental to the public interest. *This provision shall not be construed to allow any public agency to prohibit access to a record of that agency that was open for public inspection, examination, or copying before the investigation commenced.* (“**Denied**” under N.J.S.A. 47:1A-3.a)
