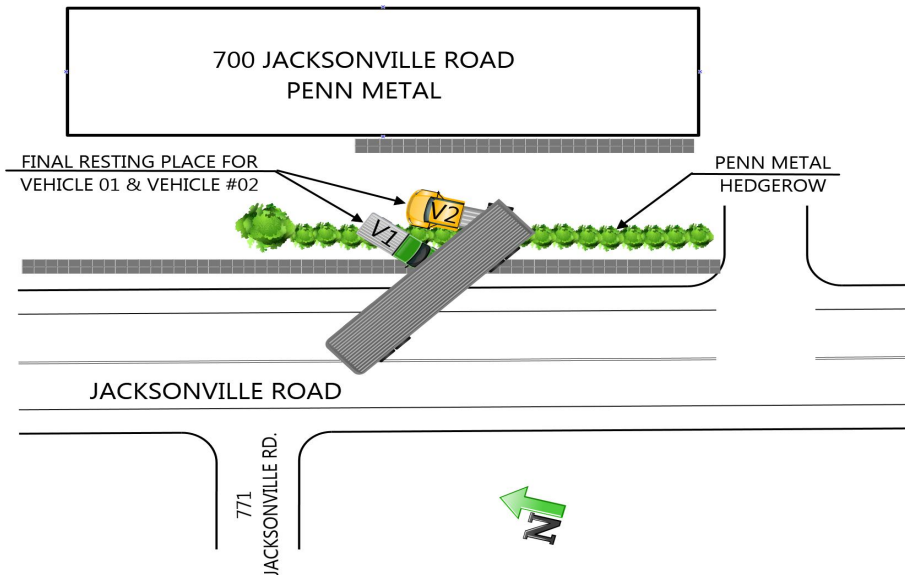

145 Crash Description/Narrative

During police investigation, the driver of V-1 stated to the effect he had just left WAWA in Burlington City when he blacked out. When he awoke back up, he was under the tractor trailer. Driver of V-1 further stated he suffers from seizures and epilepsy since he was a kid. The passenger of V-1 stated to the effect, he had seen his friend go into seizures after crossing over the intersection of RT.130N & Jacksonville Road. When the driver had gone into seizure, the driver continued to accelerate with his foot stuck on the gas. He tried reaching over to push the brake pedal and stop the V-1 but was unable to so he grabbed the steering wheel, causing his vehicle to pass several vehicles to the right. When he had seen on coming traffic he had no choice then to veer to the right hitting vehicle #02. Driver of V-2 stated to the effect he was driving on South on Jacksonville Road when all of a sudden he felt in impact from V-1 which caused his tractor trailer to jack knife, then coming to a complete stop in front of Penn Metals Hedgerow bushes.

Several witnesses to the accident stated to the effect, the driver of V-1 lost control of his vehicle and started driving on the other side of the road, then swerved back to the right hitting V-2.
