The Evesham Township Police Department received your OPRA request on **July 26, 2023**. The Evesham Township Police Department Records Custodian received your OPRA request on **July 31, 2023**. The seven (7) business day deadline to respond to your request is **August 9, 2023**. A partial response, special service fee advisement and request for clarification was sent to you on **August 1, 2023**; clarification was provided on **August 2, 2023**. A request for extension to **August 17, 2023** was sent to you on **August 9, 2023**. This final response to your request is being sent to you within the extension period.

The link is valid for 21 days for you to download the videos for your records. Please note the retention period for videos is three years.**

At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.

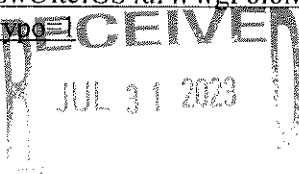
