Dear Anonymous,

This office received your records request dated January 20, 2020 via e-mail on January 20, 2020 and it was received by the records custodian on the same date. You requested the following:

Records requested:

1. Motor Vehicle Accident Report involving Roselle police officer on Broad St in Matawan, NJ on Sunday 01/19/2020.
2. I seek all information available pursuant to N.J.S.A. 47:1A-3(b) regarding the motor vehicle accident on Broad St in Matawan, NJ on Sunday 01/19/2020.

1. This office does not have a copy of the NJTR1 report. You may wish to contact the Matawan Police Department.
2. N.J.S.A. 47:1A-3b states, in pertinent part, that the following information concerning a criminal investigation shall be available to the public within 24 hours or as soon as practicable upon request:

- where a crime has been reported but no arrest yet made, information as to the type of crime, time, location and type of weapon, if any;

* No crime was reported and no arrest was made.

- if an arrest has been made, information as to the name, address and age of any victims unless there has not been sufficient opportunity for notification of next of kin of any victims of injury and/or death to any such victim or where the release of the names of any victim would be contrary to existing law or Court Rule. In deciding on the release of information as to the identity of a victim, the safety of the victim and the victim's family, and the integrity of any ongoing investigation, shall be considered;

* No arrest was made.

- if an arrest has been made, information as to the defendant's name, age, residence, occupation, marital status and similar background information and, the identity of the complaining party unless the release of such information is contrary to existing law or Court Rule;

* No arrest was made.

- information as to the text of any charges such as the complaint, accusation and indictment unless sealed by the court or unless the release of such information is contrary to existing law or court rule;

* No complaints were signed.

- information as to the identity of the investigating and arresting personnel and agency and the length of the investigation;

* Sgt. Kevin Condon (Monmouth County Prosecutor's Office) and Det. Eric Andersen (Matawan Police Department) are the investigators. The length of the investigation is 4 days.

- information of the circumstances immediately surrounding the arrest, including but not limited to the time and place of the arrest, resistance, if any, pursuit, possession and nature and use of weapons and ammunition by the suspect and by the police;

* No arrest was made.

- information as to circumstances surrounding bail, whether it was posted and the amount thereof.

* No arrest was made.

In the event of a clarification or appeal, this office reserves the right to raise any other ground for denial not raised in this response. The failure of this office to assert an exception or privilege at this time does not act as a waiver of any grounds for denial.
