

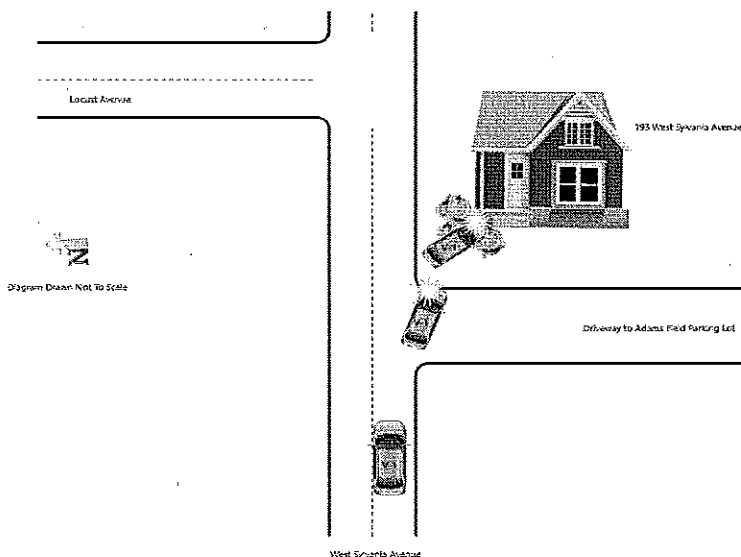

Witness: Dale Degraw, 150 Howell Rd, Freehold, NJ 07728

Patrols responded to the area of Ricks Farmers Market (66 Locust Avenue) for a report of a motor vehicle accident. The caller, an off-duty Monroe Township Police Officer, advised he was following the accused vehicle into Belmar and that the accused vehicle had possibly struck a building. I arrived and observed no damage to the farmers market. Dispatch advised that Belmar Police units were out with the witness and the accused vehicle at the Dollar General in their town.

I responded to the Dollar General in Belmar and made contact with Belmar Police units on scene. They advised that the witness, identified as Dale Degraw, was traveling on West Sylvania Avenue when he saw the accused vehicle backing off the front lawn of 193 West Sylvania Avenue. Believing the vehicle may have been involved in an accident and was leaving the scene, he contacted 911 and followed the vehicle until it stopped in Belmar. Sergeant Mazzeo responded to 193 West Sylvania Avenue where he observed damage to some shrubs in front of the building and damage to the front northwest corner of the building. Photographs of the damage were taken and are attached to this report. Sergeant Mazzeo also contacted the building owner, Patricia Cartagena, who later responded to the scene and provided her home owners insurance for the building. Cartagena stated the cost to repair the damage to the shrubs and building is unknown right now.

I then spoke with the driver of Vehicle 1. She advised she was traveling east on West Sylvania Avenue. She stated her vehicle began to hydroplane due to the slippery road conditions. She said her vehicle struck the curb located in front of 193 West Sylvania Avenue and after mounting the curb, struck some shrubbery on the property before striking the building and coming to a stop. She advised she was not hurt as a result of the crash. After attempting to make contact with someone in the building with no success, she said she needed to use the bathroom and left the scene. She arrived at her salon in Belmar when she was contacted by Belmar Police units.
