Good day,

The Ocean County Sheriff's Office received your Open Public Records Act (OPRA) request on or about August 6, 2025. The official Records Custodian, Michael J. Zolezi, received your OPRA request on August 6, 2025.

The following records were requested:

- "I Please provide an export of the fields of digital data contained within the Active911 dispatch software in electronic spreadsheet (Excel or CSV) format detailing all alarms/calls for April 1-11 and July 1, 2025-July 31, 2025 (redacting/excluding call comments). There is an Active911 account created under the name "Ocean County Fire & EMS" registered to the department's address at 138 Chestnut Street, Toms River, so that is the account I am referring to. (Please note, in my request from last month, the data for April 1-April 11 was requested but not sent in the response, so that is why I am asking for these dates again)."

The following is a line-by-line response to your requested items.

A. Requested records

1. Ocean County Fire and EMS Active911 report for July 2025. **See Attached report.**

2. Ocean County Fire and EMS Active911 report for April 1-11, 2025. The entire report is not available due to a server issue; April 11 to the end of April is the only April data that is available.

This response is being communicated with you via e-mail.

OPRA: RIGHT OF APPEAL

If your request for access to a government record has been denied or unfilled within the seven (7) or fourteen (14) business days required by law, you have a right to challenge the decision by the responding agency to deny access. At your option, you may either: 1) institute a proceeding in the Superior Court of New Jersey; or 2) file a complaint with the Government Records Council ("GRC") by completing the Denial of Access Complaint Form. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
