Good day Resident,

The Ocean County Sheriff's Office received your Open Public Records Act (OPRA) request on or about July 1, 2021. The official Records Custodian, Lt. Adrian Bullock, received your OPRA request on July 6, 2021. Public Law 2020 c. 20 provides that during a period declared pursuant to the laws of this State as a state of emergency, public health emergency, or state of local disaster emergency, the deadlines by which to respond to a request for, or grant or deny access to, a government record under the Open Public Records Act shall not apply.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the Ocean County Sheriff's Office to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. 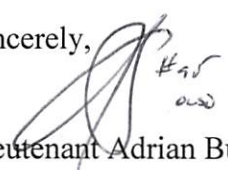
