Good day Resident,

The Ocean County Sheriff's Office received your Open Public Records Act (OPRA) request on or about June 1, 2022. The official Records Custodian, Lt. Adrian Bullock, received your OPRA request on June 1, 2022.

The following records were requested: "Please provide an export of the fields of digital data contained within the Active911 dispatch software in electronic spreadsheet (Excel or CSV) format detailing all alarms/calls for May 1, 2022 to May 31, 2022 (redacting/excluding call comments). There is an Active911 account created under the name "Ocean County Fire & EMS" registered to the department's address at 138 Chestnut Street, Toms River, so that is the account I am referring to."

The following is a line by line response to your requested items.

A. Requested records

I. Export of the fields of digital data contained within the Active911 dispatch software in electronic spreadsheet (Excel or CSV) format detailing all alarms/calls for May 1, 2022 to May 31, 2022 (redacting/excluding call comments). Records stemming from an Active911 account created under the name "Ocean County Fire & EMS" registered to the department's address at 138 Chestnut Street, Toms River.

This response is being communicated with you via e-mail as per your request.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the Ocean County Sheriff's Office to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc.

The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
