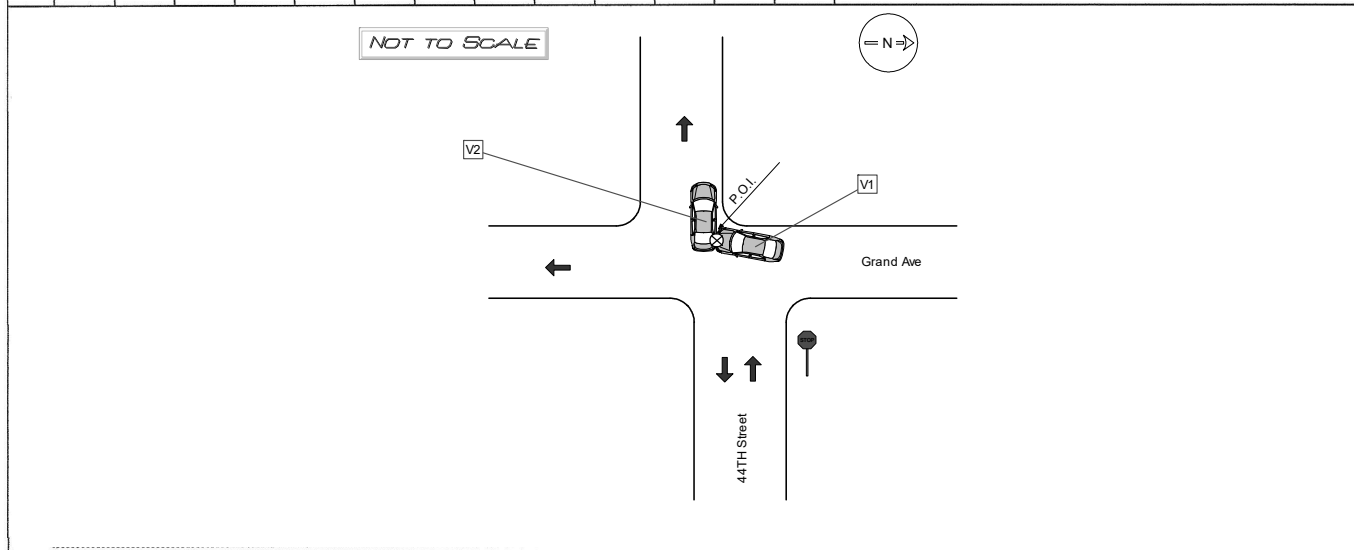

145. Crash Description/Narrative

Driver of vehicle 1 stated that he was driving southbound on Grand Ave when he collided with vehicle 2. He attempted to avoid the collision with vehicle 2 by steering away from vehicle 2, but could not stop in time. Vehicle 1 sustained moderate damage to the front bumper of the vehicle.

Driver of vehicle 2 stated she stopped for the stop sign on 44th street and Grand Ave going westbound. As she proceeded to drive westbound on 44th street, vehicle 1 suddenly collided with her vehicle. Vehicle 2 sustained moderate damage to the rear passenger fender and wheel. Vehicle 2 was disabled and towed by Tumino's Towing Company.
