Supplement

On the above date and time, I Ptl. Chelston (#297) and Ptl. Miserendino (#285) responded to 149 Brindletown Road in reference to a reported disturbance. The caller, Albert Canka, informed Ocean County Dispatch that an individual had vandalized the front gate of his farm property. Although Mr. Canka was not present at the time, he was notified by a tenant, Tina Vega. Upon arrival, officers spoke with Ms. Vega, who reported hearing a loud banging noise near the front gate around 20:30 hours. After reviewing the farm's security footage, she observed an individual, identified as Danilee Watkins, using a sledgehammer to strike both the gate and a wooden post multiple times, resulting in visible property damage. The video further showed Mr. Watkins forcibly removing the post from the ground and throwing it over the fence. Following this act, he was heard saying, "What now." Ms. Vega was able to provide me with the security footage so it can be attached to this report.

Officers made contact with Mr. Watkins regarding the incident. He stated that his actions were motivated by his belief that Mr. Canka is not the rightful owner of the farm and that the front gate in question belongs to him. Mr. Watkins claimed that Mr. Canka had been unlawfully locking the gate, thereby preventing him from accessing the property. In response, Mr. Watkins admitted to forcibly removing both the lock and the wooden post, which he asserted were obstructing his access. Based on the circumstances and the property damage caused, Mr. Watkins was placed under arrest for Criminal Mischief.

At this time, Mr. Watkins was placed in handcuffs, which were double-locked, and searched for weapons or contraband with negative results. He was then escorted to my patrol vehicle (Unit #2308). Prior to placement, a rear seat inspection for contraband was conducted, yielding negative results. Mr. Watkins was secured in the back seat with a seatbelt, and I notified Ocean County Dispatch of my starting and ending mileage before transporting him to Police Headquarters.

Upon arrival, another rear seat inspection was completed with no contraband found. Mr. Watkins was then secured to the processing room bench using an ankle cuff. I secured my duty weapon in the designated armory and began processing procedures. It should be noted that Mr. Watkins remained under continuous monitoring by security cameras throughout his time in custody.

Mr. Watkins was charged with Criminal Mischief (N.J.S.A. 2C:17-3A(1)) under complaint number 1523-W-2025-000047. He was processed, placed on a warrant, and subsequently transported to Ocean County Jail without incident. Ocean County Dispatch was advised of both the starting and ending mileage for the transport. All relevant documentation has been completed and will be attached to this report. No further police actions taken at this time.
