On the above date and time I (Patrolman Manata #294) received a walk in at headquarters for theft of property.

I made contact with Dan Watkins and Wayne Giquinto who wanted to report theft of property at 149 Brindletown Road (Green Cells Farm). Dan stated at their recent court hearing, the Judge advised Dan to file a report for theft of property with the Plumsted Police. Dan and Wayne have both attempted to contact Albert by phone and email with no response. This officer attempted to make contact with Albert but was unsuccessful at this time. I advised Dan and Wayne that this officer will document all information in the report and have Sgt. Schaal #266 investigate the incident. I was clear from the incident with no further action taken.

It should be noted Dan is concerned for the 10 pounds of Cannabis that's on the property due to Albert illegally withholding Dan from receiving property. All property and values are listed below.

On the 12/15/2025, I attempted to contact Wayne Giquinto multiple times and was unsuccessful at this time. BWC was not activated for phone call.

Supplement

I (Sergeant Gary Schaal #266) spoke with the property owner of 149 Brindletown Road, New Egypt NJ 08533, Albert Canka, on Wednesday 12/03/2025. Mr Canka had stated Danilee Watkins was evicted from the property in July/ August of 2025 by the Ocean County Sheriffs Department. Mr Watkins was given notice of the eviction and time to remove his property/ equipment before being evicted and failed to do so. Mr Canka stated he does not know exactly what items remain on the property, but stated they are locked inside one of the barns on the premise. Mr Canka further stated he was advised by his attorney that he is no longer obligated to allow Mr Watkins back on the property as he failed to remove his belongings during the eviction process. The theft report Mr Watkins has filed here, is a civil matter to be handled by the judge.
