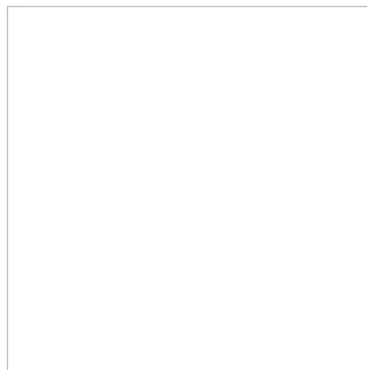

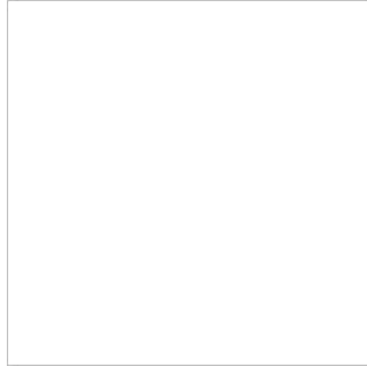

5. Board policy indemnifies Board members "in accordance with law whenever a civil, administrative, criminal or quasi-criminal action or other legal proceeding is brought against a Board member." However, Board policy does not provide Board members with legal fees related to your pursuit of committee appointments. Any legal fees related to your appointment or non-appointment to Board committees or not related directly to your defense against the ethics violation filed with the SEC should not be submitted by you to the Board for reimbursement.

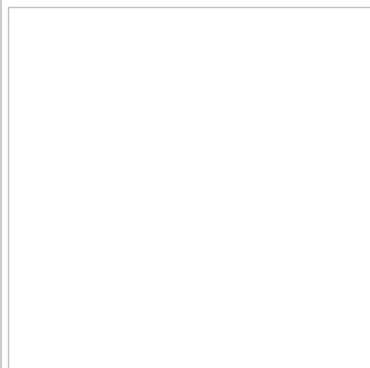

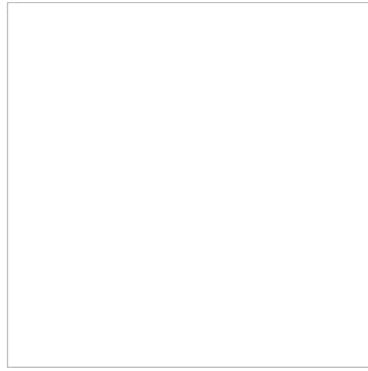
