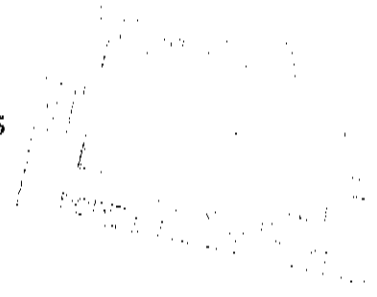

WHEREAS, a recent poll taken by Fairleigh Dickinson University found that 58 percent of those polled believe the State should not legalize marijuana for recreational use, highlighting a trend which shows support for legalization declining in recent years; and

WHEREAS, Colorado, one of the states that has legalized recreational marijuana, has seen an increase in documented traffic deaths involving drivers that had used marijuana as well as increased use in teens aged 12 to 17 that is 74% above the national average; and

WHEREAS, recreational marijuana is specifically designed to have as much THC as possible;
and

WHEREAS, THC is known to impair physical function in the user, including reaction time while operating a vehicle and the user's ability to perceive danger; and

WHEREAS, New Jersey utilizes Drug Recognition Experts, "DRE" to determine whether someone is under the influence of a drug when operating a motor vehicle; and

WHEREAS, New Jersey has a standard established for Driving While Intoxicated, .08%, however, since marijuana THC is known to stay in a person's system for up to 30 days, there is no current test or standard established for operating a motor vehicle under the influence of marijuana, making enforcement difficult; and

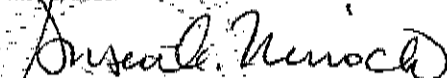
WHEREAS, Monmouth County and several municipalities in Ocean County, including Point Pleasant Beach, Berkeley Township and Bay Head have already passed Ordinances to ban sales in their jurisdiction with Toms River Township, Ocean Gate and Lavallette strongly considering similar ordinances; and

NOW, THEREFORE, BE IT RESOLVED, that the Borough of Beachwood Mayor and Council, of the County of Ocean, State of New Jersey hereby opposes the enactment of legislation to legalize the recreational use and sale of marijuana; and further encourage Ocean County municipalities to join with Ocean County in opposing this issue.

BE FURTHER IT RESOLVED, that certified copies of this resolution shall be made available to Governor Phil Murphy, the 3rd, 9th, 10th, 12th, and 30th Legislative Districts representatives, Ocean County Freeholders, Ocean County mayors, Prosecutor Joseph Coronato, Sheriff Michael Mastronardy, Ocean County Chiefs of Police and the New Association of Counties.

Our Child Break presentation is a multimedia program that informs, encourages and empowers parents, grandparents, educators, coaches, and other adult caregivers how to communicate effectively with children about the misuse and abuse of alcohol and other drugs. The presentation includes up to date statistics on drug and alcohol use and public service announcements that cover various types of drugs used by children. Specific topics addressed include underage drinking, marijuana use, the current opiate/heroin crisis we are currently facing throughout our state, risk factors and protective factors, and specific strategies parents may use with their children. The American Academy of Pediatrics has recently promoted guidelines encouraging parents and guardians to talk to their children about this issue as early as age 9.

When doing the presentation for seniors, specific attention is, to note seniors themselves are an "at risk" population. Over 2.7 million people over age 50 abused painkillers and over 14,000 people over age 45 died of overdoses in 2015.

We need you, now! We are quickly approaching a crucial situation with regard to the legislation to legalize marijuana in New Jersey. The legislature will return in September and this will be the major issue on the docket as Senate leadership hope to have a bill ready for the Governor to sign by late October.

As the only group united in the fight against legalized marijuana in the state, NJ-RAMP will continue to lead this opposition effort with the support of all of our advocacy partners such as you!

To do so, we must be focused on the following goals:

- Educate members of the Senate Judiciary Committee on the dangers of moving such legislation and negative impact it will have on NJ communities through one-on-one meetings

I wanted to share with Mayor Reid the attached piece which we have sent to State Assemblypersons and State Senators who are engaged in the potential passage of Marijuana legalization in New Jersey. I am hoping that you can please forward this email to him.

The legalization of marijuana can provide the opportunity for the investment in housing as reparative justice. Opportunity starts at the local level for impacted communities and impacted individuals. More detail about our proposal for how to ensure this is below and in the attached document.

We would be happy to meet with you and your staff to discuss and answer any questions that you might have about our proposal and the opportunity for investing in housing.

The passage of marijuana legalization provides the opportunity to address legal justice, economic access, housing, substance abuse treatment and mental health treatment and access to support services. Each of these cornerstones could have a significant and direct impact on stabilizing communities and creating opportunities for those directly impacted by drug policies and disparate targeting by law enforcement.

In addition to targeting and spending a portion of the increased revenue on evidenced based substance abuse treatment programs, a portion of the State of New Jersey's new revenue should be spent on housing. Supportive housing has been proven to both prevent and end homelessness, stabilize communities, and stabilize lives, including the lives of those receiving substance abuse treatment and in recovery. Housing is an important component of successful recovery. Individuals offered substance abuse treatment through proposed centers treating intoxicated drivers should be given supportive housing opportunities and access to services to be able to stabilize their lives and connect people back to their own communities.

Supportive housing opportunities funded through the tax revenue from legalized marijuana should include

- Earmarking 20% of the new tax revenue for the State's Special Needs Housing Trust Fund;

- The earmarked 20% of new revenue should be used for housing vouchers and supportive housing requiring that both impacted communities and persons experiencing addiction receive priority for receiving housing;
- Using 20% of any local fees added on at the municipal level to create new supportive housing in the local community for populations in the greatest need including household experiencing addiction who need housing to succeed in recovery;
- 20% of the \$127 million spent annually on marijuana possession enforcement costs should be reinvested into support services that will help impacted individuals and impacted communities succeed in the supportive housing created; and
- Individuals with criminal records from drug related crimes should be given equal access to newly created supportive housing by waiving criminal background restrictions.

The State can work with local mayors to identify and prioritize impacted communities where housing programs funded through the special needs housing trust fund can be implemented. Local communities can use data around the impact in their community to respond to a Request for Proposal (RFP.) The RFP would fund supportive housing and include services funding through the enforcement cost savings to provide the support in the supportive housing. Communities most impacted will receive bonus points in the RFP application process.

A significant portion of funding generated through marijuana legalization should be earmarked for reparative justice initiatives including specifically, funding for housing for those in the greatest need including those who need housing to succeed in their recovery. Opportunity starts at home and we know that stable housing is the foundation from which people can build healthy and productive lives.

The passage of marijuana legalization provides the opportunity to address legal justice, economic access, housing, substance abuse and mental health treatment and access to support services. Each of these cornerstones could have a significant and direct impact on stabilizing communities and creating opportunities for those directly impacted by drug policies and disparate targeting by law enforcement.

In addition to targeting and spending a portion of the increased revenue on evidenced based substance abuse treatment programs, a portion of the State of New Jersey's new revenue should be spent on housing. Supportive housing has been proven to both prevent and end homelessness, stabilize communities, and stabilize lives, including the lives of those receiving substance abuse treatment and in recovery. Housing is an important component of successful recovery. Individuals offered substance abuse treatment through proposed centers treating intoxicated drivers should be given supportive housing opportunities and access to services to be able to stabilize their lives and connect people back to their own communities.

Supportive housing opportunities funded through the tax revenue from legalized marijuana should include:

1. Earmarking 20% of the new tax revenue for the State's Special Needs Housing Trust Fund;
2. The earmarked 20% of new revenue should be used for housing vouchers and supportive housing requiring that both impacted communities and persons experiencing addiction receive priority for receiving housing;
3. Using 20% of any local fees added on at the municipal level to create new supportive housing in the local community for populations in the greatest need including household experiencing addiction who need housing to succeed in recovery;
4. 20% of the \$127 million spent annually on marijuana possession enforcement costs should be reinvested into support services that will help impacted individuals and impacted communities succeed in the supportive housing created; and
5. Individuals with criminal records from drug related crimes should be given equal access to newly created supportive housing by waiving criminal background restrictions.

The State can work with local mayors to identify and prioritize impacted communities where housing programs funded through the special needs housing trust fund can be implemented. Local communities can use data around the impact in their community to respond to a Request for Proposal (RFP.) The RFP would fund supportive housing and include services funding through the enforcement cost savings to provide the support in the supportive housing. Communities most impacted will receive bonus points in the RFP application process.
