



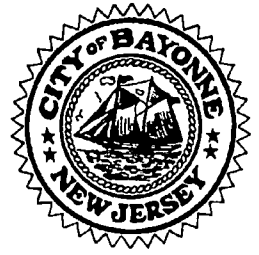

Dear Mr. Grimes:

The City of Bayonne received your Open Public Records Act (OPRA) request on November 16, 2020. The official Records Custodian, Madelene C. Medina, received your OPRA request on November 16, 2020. As such, the seven (7) business day deadline to respond to your request is November 25, 2020.

Your OPRA request sought access to the following: Please see attached OPRA.

Currently, your request is overly broad and fails to identify with reasonable clarity the specific government records sought, as is required by *Bent v. Stafford Police Department*, 381 N.J.Super. 30, 37 (App. Div. 2005). At this time, we request clarification of your OPRA request. Please respond in writing and identify the specific department(s) for government records sought so that we may process your request. Failure to provide written clarification of your request within seven (7) business days will result in the closure of this OPRA request.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the City of Bayonne to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form.

You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
