Mr. Palino

As you are fully aware, you filed a complaint against me for the following 3 charges of disorderly conduct (2C:33-8, A: 9-49A & A:9-49H) one of which is a criminal offense. The criminal offense could be subject to imprisonment for a term not to exceed 6 months or shall pay a fine not to exceed \$1,000.00 or to both a fine and imprisonment, in the discretion of the court. In said violation you indicated that I refused to wear a facial covering. I had my mask on, it was black, and I have many witnesses that will provide testimonies and/or affidavits upon request. You accused the wrong person in an effort to harass, intimidate and bully others into submission.

On January 12, 2022, via the BOE meeting on zoom you proceeded to threaten me further stating "if you continue to come to these meetings unmasked and I know your name, more charges will be filed."

At this time, I have spoken to counsel but have not retained the same. Against counsel's recommendation, I would like to give you an opportunity to do the right thing. I have been advised by counsel that I will be able to file harassment, malicious prosecution and other claims against you but have not done so at this time. To be honest, that is not something I would like to do but you may leave

me with no choice. My name and reputation is everything to me and I will not let anyone make frivolous claims against it.

Mr. Palino, I hereby request the following items:

1. All charges against myself and my co-defendants in complaint 1512 S 2022 000024 are dropped completely by you.
2. A public apology to myself along with all defendants named in above complaint
3. The Lacey township board of Education meetings to be held off school property so that those that want to attend meetings are welcomed UNMASKED.

If you are unwilling to move forward with my above requests then kindly accept this email as my formal request for any evidence and witnesses that you will be providing as discovery to the court. I am requesting same to be sent to me immediately.

I will await your response.
