I, Kristen Pedersen, residing at [REDACTED] Westwood, NJ 07675 (cell phone: [REDACTED]) request the School Ethics Commission to consider a complaint against the above-named Respondent(s) whose home address is [REDACTED] Westwood, NJ 07675, in accordance with the authority of the School Ethics Commission to entertain such complaints under N.J.S.A. 18A:12-21 et seq.

The facts upon which this complaint is based are as follows: *(Please print additional pages as needed. Students should be identified by initials only.)*

1. Statement of facts:

On May 4, 2021, the Westwood Regional School District (“WWRSD”) Superintendent, Dr Raymond Gonzalez, notified district families of his resignation, effective August 1, 2021. This resignation followed months of outrage from district families stemming from concerns surrounding Dr. Gonzalez’s lack of leadership, honesty, transparency and acting in the best interest of students. Many of these upset parents vocalized their concerns during the monthly Board of Education (“BOE”) meeting public sessions leading up to this date. Please refer to **Exhibit A** for email communication from Dr. Gonzalez to the district community regarding the resignation.

2. Statement of facts:

On May 10, 2021, the BOE President, Matthew Perrapato, and BOE Vice President, Joseph Abou Daoud, co-issued an e-mailed letter to the community expressing their regret of Dr. Gonzalez’s resignation, publicly appraising the Superintendent, and discussing the plans to backfill the position. It was later admitted that Perrapato and Abou Daoud refused input from their fellow Board members, and that their fellow Board members did not agree with the wording of this letter. Date of occurrence: May 10, 2021.

I assert this to be a violation of: School Ethics Act 18A: 12-24.1d, 1e because Joseph Abou Daoud did not work together with his fellow board members to prepare this statement. Rather, he and Perrapato refused the suggestions provided by fellow board members. Abou Daoud and Perrapato's admitted guilt to plagiarism which compromised the integrity of the entire board. The board is a reflection of the school district and it cannot be led by hypocritical individuals who clearly commit violations of the same policies (plagiarism) that they hold students to.

d. I will carry out my responsibility, not to administer the schools, but, together with my fellow board members, to see that they are well run.

e. I will recognize that authority rests with the board of education and will make no personal promises nor take any private action that may compromise the board.

3. Statement of facts:

On May 13, 2021, during the monthly BOE meeting, it was brought to light that the May 10th letter disseminated by Perrapato and Abou Daoud was completely plagiarized and stolen from another New Jersey school district. Please refer to **Exhibit C** for original statement, which is dated July 14, 2019 and belongs to the Montclair public school district. Certain Board members expressed concern over this letter because the Board was not permitted by Perrapato and Abou Daoud to contribute to the authoring of the communication, and many members did not agree with the sentiment of regret. When asked to address the plagiarism, Mr. Perrapato's behavior was disgusting. Mr. Perrapato stated numerous times that he did nothing wrong and that he was not apologizing. Several other Board members called for his and Mr. Abou Daoud's immediate resignation due to their unethical behavior and putting the entire Board at risk. Several other Board members engaged in screaming matches at each other, while others later issued disparaging remarks to and about members of the public.

Date of occurrence: May 10, 2021.

I assert this to be a violation of: School Ethics Act 18A: 12-24. 1a, 1b, 1d, 1e because Abou Daoud's actions did not uphold the rules and regulations of the State Board of Education when he plagiarized a letter sent to the community. This behavior was a very poor example to the educational welfare of the district children, as it violated plagiarism policies in place across the district. This behavior was opposed by fellow board members and compromised the integrity of the entire board.

a. I will uphold and enforce all laws, rules and regulations of the State Board of Education, and court orders pertaining to schools. Desired changes shall be brought about only through legal and ethical procedures.

b. I will make decisions in terms of the educational welfare of children and will seek to develop and maintain public schools that meet the individual needs of all children regardless of their ability, race, creed, sex, or social standing.

d. I will carry out my responsibility, not to administer the schools, but, together with my fellow board members, to see that they are well run.

e. I will recognize that authority rests with the board of education and will make no personal promises nor take any private action that may compromise the board.

4. Statement of facts:

As a result of this 7 hour long, atrocious meeting, an approximate 5 minute long recap of the meeting, particularly focused on the BOE's many forms of unethical behavior (plagiarism, disparaging remarks to and about members of the public, members actions which jeopardized the integrity of the entire Board) was created and posted to YouTube. This 5 minute recap includes the following disclaimer:

"This video contains various clips of ethical misconduct and inappropriate behavior by certain members of the BOE which occurred throughout the duration of a 7 hour long meeting (held on May 13, 2021). You are encouraged to watch the full 7 hours for full context of the clips shown in the 5 minutes here. This video is only intended to provide a brief recap of the many forms of misconduct displayed throughout the meeting, including but not limited to plagiarism and BOE members making disparaging remarks of the public community members."

5. Statement of facts:

On May 19, 2021, Mr. Perrapato issued a public apology for his plagiarism. Please refer to **Exhibit D** for this communication.

During the weeks after this May 19th communication, the Westwood and Washington Township communities continued to express outrage over the acts of plagiarism conducted by Mr. Perrapato and Mr. Abou Daoud, and continued to call for their resignations. Members of our community called for the removal of plagiarism policies for the children of the district if BOE leadership was evidently guilty of such and no action was taken against them. How can our children possibly be held to higher standards than the President and Vice President of our Board of Education? The outrage and upset was vocalized by countless parents across many social media platforms, during subsequent BOE meeting public sessions and across the community.

6. Statement of facts:

At the June 30, 2021 BOE meeting, it was announced that Mr. Perrapato had resigned. While no explanation or reasoning was provided for his resignation, the parents of our district were overwhelmingly pleased with the news. However, many of us are still awaiting the resignation of the co-plagiarizer, Mr. Abou Daoud, and wondering why that has not yet occurred.

7. Statement of facts:

On July 2, 2021, I received a FedEx letter which was left on my doorstep while I was away out of state. The only reason I know it was delivered on July 2 is because my home security system has the delivery recorded. Please refer to **Exhibit E** to review what was contained within that FedEx delivery. A very similar letter was also sent to Mr. Douglas Cusato, a Washington Township NJ resident. It is unclear at this time if similar letters were sent to additional members of the public.

The letter dated July 2, 2021 is grossly inappropriate and is a disgusting attempt by Mr. Abou Daoud to silence, intimidate, retaliate against, and harass members of the public who have vocally called out his unethical behavior. This letter is a false allegation against me and Mr. Cusato, it is defamatory, and it has no merit. My actions to date have been nothing except honest and sincere. I have and will continue to advocate for better leadership within our Board of Education. Mr. Abou Daoud has acted with zero integrity, zero honesty and extremely unethically.

Date of occurrence: July 2, 2021.

I assert this to be a violation of: School Ethics Act 18A:12-24.1a, 1d, 1e, 1f, 1g because one single member of the board is now attempting to make false allegations, intimidate and harass members of the public who have called out his unethical behavior. The letter I received was reviewed by other attorneys and deemed to have no merit whatsoever. Board members should never retaliate against the public's good intentions simply because they do not agree. Further, I have learned that Abou Daoud's fellow board members were not aware he sent this legal letter to myself and Cusato, again acting as a sole person rather than one of nine. Abou Daoud's actions continue to compromise the entire board. Lastly, Abou Daoud appears to be using his position as Board Vice President for his own personal gain. Why would he insinuate that members of the public calling out his unprofessional and unethical behavior as it relates to the Board are now impacting his personal livelihood? These are two totally independent things.

- a. I will uphold and enforce all laws, rules and regulations of the State Board of Education, and court orders pertaining to schools. Desired changes shall be brought about only through legal and ethical procedures.
- d. I will carry out my responsibility, not to administer the schools, but, together with my fellow board members, to see that they are well run.
- e. I will recognize that authority rests with the board of education and will make no personal promises nor take any private action that may compromise the board.
- f. I will refuse to surrender my independent judgment to special interest or partisan political groups or to use the schools for personal gain or for the gain of friends.
- g. I will hold confidential all matters pertaining to the schools which, if disclosed, would needlessly injure individuals or the schools. In all other matters, I will provide accurate information and, in concert with my fellow board members, interpret to the staff the aspirations of the community for its school.

8. Statement of facts:

Furthermore, it has come to my attention that some if not all the legal expense incurred because of these frivolous claims against me are being paid for with taxpayer dollars. Additionally, as we can see on the legal invoice (**Exhibit F**), the current Superintendent, Dr. Raymond Gonzalez, appears to have initiated the legal guidance that resulted in me receiving the July 2nd letter. What vested interest would a Superintendent have in helping a Board of Education President attack a member of the public? Doesn't the Superintendent report to the BOE? This appears to be a conflict of interest. A Board President can't possibly be responsible for evaluating the performance and success of a Superintendent if the Superintendent is helping that President cover up ethical misconduct and helping that President attack members of the public who bring it to light.

I assert this to be a violation of: School Ethics Act 18A:12-24 Conflict of Interest 12a, 12b, 12c, 12d, 12e, 12f AND School Ethics Act 18A: 12-24. 1i because Abou Daoud is now mixing his role as Board VP with his personal business ventures, as he mentions in the legal letter sent to me. Abou Daoud is using taxpayer dollars to benefit his personal life, as shown when the Board was sent a legal invoice for legal work performed related to his letter. This is accepting a gift of legal service to benefit his personal endeavors.

18A:12-24. Conflicts of interest

- a. No school official or member of his immediate family shall have an interest in a business organization or engage in any business, transaction, or professional activity, which is in substantial conflict with the proper discharge of his duties in the public interest;
- b. No school official shall use or attempt to use his official position to secure unwarranted privileges, advantages or employment for himself, members of his immediate family or others;
- c. No school official shall act in his official capacity in any matter where he, a member of his immediate family, or a business organization in which he has an interest, has a direct or indirect financial involvement that might reasonably be expected to impair his objectivity or independence of judgment. No school official shall act in his official capacity in any matter where he or a member of his immediate family has a personal involvement that is or creates some benefit to the school official or member of his immediate family;
- d. No school official shall undertake any employment or service, whether compensated or not, which might reasonably be expected to prejudice his independence of judgment in the exercise of his official duties;
- e. No school official, or member of his immediate family, or business organization in which he has an interest, shall solicit or accept any gift, favor, loan, political contribution, service, promise of future employment, or other thing of value based upon an understanding that the gift, favor, loan, contribution, service, promise, or other thing of value was given or offered for the purpose of influencing him, directly or indirectly, in the discharge of his official duties. This provision shall not apply to the solicitation or acceptance of contributions to the campaign of an announced candidate for elective public office, if the school official has no knowledge or reason to believe that the campaign contribution, if accepted, was given with the intent to influence the school official in the discharge of his official duties;
- f. No school official shall use, or allow to be used, his public office or employment, or any information, not generally available to the members of the public, which he receives or acquires in the course of and by reason of his office or employment, for the purpose of securing financial gain for himself, any member of his immediate family, or any business organization with which he is associated;

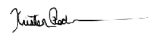
i. I will support and protect school personnel in proper performance of their duties.

I am respectfully requesting that Mr. Abou Daoud be removed from the Westwood Regional School District Board of Education for the violations previously listed.

Dear Westwood Regional School Community,

First, I would like to acknowledge and take complete responsibility for the May 10 message that I sent using the words of another school district to inform you of the next steps in our search for a new superintendent. Following the formal resignation of the Superintendent which coincided with the birth of my third son, my primary intention was to get a message out to the school community as soon as possible using an announcement I found online as my template. There was no malicious intent in my action and I sincerely apologize for it. I want to reiterate that I remain fully committed to my role as a member of this Board, demonstrating ethical leadership, and doing what is best for ALL of our children.

Next, I would like to share the latest developments regarding the search for a new superintendent as a result of action taken by the Board of Education on May 13. During the public meeting, the Board approved three motions to direct the Board Secretary / School Business Administrator to:

- Request any current lists of interim Superintendents from the NJ Department of Education, the NJ School Boards Association, the NJ Association of School Administrators, and the NJ Association of School Business Officials.
- Advertise as needed and appropriate.
- Formally solicit proposals for search firms who can work with the Board to conduct a search for a full-time Superintendent.

In addition, pursuant to Bylaw 0155, I have created co-chair positions for the Superintendent Search Steering Committee of the Board of Education for the purpose of facilitating the general work, partnering with the Board Secretary/School Business Administrator, advising on the logistical aspects of the items listed in the previous paragraph, and providing timely updates to our school community regarding the progress of the search. The co-chairs of the ad hoc committee, who will collaborate with the other members of the Board of Education, are Ms. Roberta Hanlon and Dr. Frank Romano.

Dear Ms. Pederson:

This firm represents Joseph Abou-Daoud ("Mr. Abou-Daoud"), Vice President of the Board of Education for the Westwood Regional School District ("WWRSD").

It has come to our client's attention that on May 16, 2021, you posted a spliced video of Mr. Abou-Daoud on YouTube titled "BOE Ethical Misconduct" in an attempt to cast him in a false light and defame his character. Specifically, you altered the zoom video of the May 13, 2021 WWRSD Board meeting to mislead the public to believe that Mr. Abou-Daoud's statement, "well you have half a brain, yes I said you have half a brain" was in response to Board member Sembler's demand for him and President Matthew Perrapato to resign.¹ This is a false and misleading portrayal of what really transpired at the meeting.

The actual May 13, 2021 zoom video footage reflects that Mr. Abou-Daoud remained silent during the entire discussion and never responded to Board member Sembler's comment. Rather, Mr. Abou-Daoud's statement occurred in a totally different part of the meeting in which he

expressed support for the WWRSD teachers.² As such, Mr. Abou-Daoud's actual statement is completely different than what you intentionally and maliciously misrepresented in your May 16, 2021 "BOE Ethical Misconduct" YouTube video.

Your actions, i.e. manipulating the video to mislead the public about Mr. Abou-Daoud's statement with the intent to damage his personal and business reputation by portraying him in a false light, violate the law. Mr. Abou-Daoud is contemplating litigation against you for defamation, libel, false light, and tortious interference. Even more egregious, while altering the May 13, 2021 WWRSD Board meeting video and reposting it to YouTube, you posted the images and likeness of two high school Student Representatives, both minors, without the appropriate parental consent in violation of state and federal privacy laws.

It is hereby demanded that you must immediately **cease and desist** from making false and defamatory statements regarding Mr. Abou-Daoud and must immediately remove the May 16, 2021 YouTube posting and all other published avenues of the altered video clip. Your failure to do so may result in litigation against you.

We reserve all rights to seek damages for any actions that you have taken against Mr. Abou-Daoud to date. Additionally, if there should be any further incidents of defaming Mr. Abou-Daoud or casting him in a false light, this Firm will not hesitate to act as promptly and zealously as possible to enforce all of Mr. Abou-Daoud's legal rights. We will seek injunctive relief and will hold you individually responsible for damages to Mr. Abou-Daoud's reputation and loss of business as well as punitive damages and attorneys' fees.

Lastly, this correspondence advises you that the potential for litigation exists. Thus, it is demanded that any and all tangible and intangible information including, but not limited to correspondence, computer files, computer programs, electronic mail, text messages, word processing documents, multifunctional peripheral hard drives, computer hard drives, mobile telephone hard drives, and any and all other hard drives, memoranda and any documentation and correspondence regarding the altered video that you disseminated on the internet be preserved in each document's native format. You are specifically advised that you may not delete the May 16, 2021 "BOE Ethical Misconduct" video from your computer and any communications, including but not limited to emails and text messages to and from anyone regarding the subject matter of this video. Any destruction of the foregoing will be regarded as spoliation and trigger all appropriate legal consequences.

To immediately avoid further action, please confirm in writing **by July 9, 2021** that you have removed the video and all publications from the internet and that you further agree that you will not repost in the future. If you fail to do so, we will have no choice but to initiate legal action to rectify the damage that you have caused.

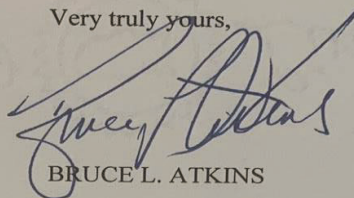
