78. Narrative On 05/06/2026 at 09:15 hours, patrol was dispatched to 51 Hibernia Avenue (The Marathon Gas Station) for the reported assault. Upon arrival, I was met by the caller (Sean Russel) who advised that the company he works for (Recharge Auto Spa) rents the garage at the gas station and they are behind on rent. Russel advised that he got into a verbal dispute with an employee from the Marathon Gas Station (Jonnathen Rodriguezchachalco) about the rent and whether or not he was permitted on the property. Both parties advised that the verbal dispute turned physical and blames the other party for it. Both parties had signs of injury on their head, face, hands, and knees. Atlantic EMS evaluated Russel for his injuries but he refused further medical attention or to be transported to the hospital. Rodriguezchachalco refused to be evaluated by Atlantic EMS. Both parties were advised of the process of filing complaints with Rockaway Township Joint Court. BWC (RBP001 & RBP011) were utilized during the incident. Nothing further at this time.
