On the above date and time I, Cpl Haefner, responded to the Home Depot for a slip and fall. Upon my arrival I found [REDACTED]. [REDACTED] said that he fell and hurt his right ankle and might not be able to drive. [REDACTED] told me to watch my step as I was standing right where he fell. I had no problem standing in a stable manner in the area. [REDACTED] asked if carts could be in the fire lane, which I found odd. The only carts in the area were on cross hatching that was not a coded fire lane, simply an area where no vehicles were supposed to be parked. When EMS arrived they saw to [REDACTED]. It should be noted that I did not see [REDACTED] fall and his statements are his own. I left the scene believing this was a medical incident. I was called back to the scene at [REDACTED] request. As I arrived a member of Milltown EMS explained that [REDACTED] refused any further care. When I approached [REDACTED] he was filming employees with his phone for some reason and, he stated that for insurance purposes he wanted a paper trail. I explained to [REDACTED] that I would be documenting our interaction. I again left believing no police presence was needed. I was called back to the scene for a third time. During this time [REDACTED] brought up several times, civil issues between him and Home Depot. I asked him multiple times if anything criminal has taken place, and he explained that there had not. [REDACTED] wanted me to have a manager of Home Depot come outside and I explained that I could not make anyone from Home Depot come out and speak to him. [REDACTED] asked that I stay on scene and I explained that this was not a police matter before I again left the scene.
