A situation occurred on Thursday, October 31st that I felt I should bring to your attention. Mayor Armstead entered our County Administration Building and requested to meet with one of the IT employees in my Department. At one point the Mayor claimed that he was in possession of an Adobe PDF file, provided to him by the Linden Board of Education which it utilizes to send notifications to students and families. He explained that the purpose of his visit was to determine if this Adobe PDF file could be converted to an Excel file so it could be used by the City.

Upon learning of the above, it occurred to me that the file provided to the Mayor may very well contain confidential information relative to students and their families. Not knowing who may have provided the Mayor with this "file" or if you were aware that same was provided, I thought it appropriate to bring this matter to your attention for whatever action you deem appropriate. Please be advised that no assistance was provided by my staff to convert the referenced data to another format.

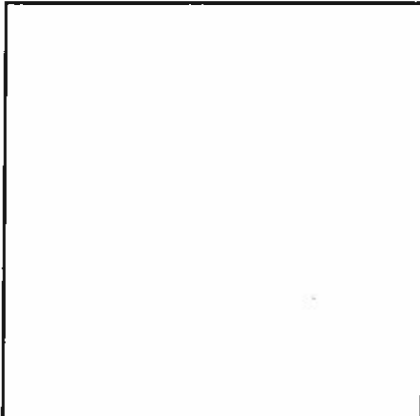
