**ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 4 –
GENERAL LICENSING SECTION 1.19 LICENSE REQUIRED, FEES**

WHEREAS, the Licensing Ordinance for the Township of Belleville specifically the "Fees" section does not have a licensing fee for hotels and motels; and

WHEREAS, the Township Mayor and Council find it prudent to add a licensing fee for hotels and motels within the Township of Belleville.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Township Council of the Township of Belleville that Chapter 4, General Licensing, specifically Section 4-1.19 License Required, Fees is hereby amended as follows:

4-1.19 License Required, Fees. Add hotel/motel keeper - \$18.00/unit.

BE IT FURTHER ORDAINED:

1. All prior ordinances inconsistent with the language hereinabove are hereby repealed.
2. This ordinance shall take effect upon passage and publication as required by law.

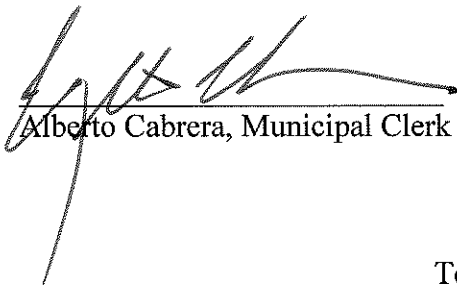
