AMENDING CHAPTER 2, SECTION 31.1, "POLICE DEPARTMENT FEES"**

BE IT ORDAINED by the Municipal Council of the Township of Belleville, County of Essex, State of New Jersey that Chapter 2, Section 31.1 entitled "Police Department Fees" in the Township of Belleville Code be and shall be amended as follows:

2-31 Fees.

Section 2-31.1 Police Department Fees (insert the following):

Application for reserved residential handicapped space \$75.00 per year
Application to renew reserved handicapped parking space \$50.00 per year

BE IT FURTHER ORDAINED by the Municipal Council of the Township of Belleville, New Jersey:

1. That the balance of the Ordinance shall remain in full force and effect.
2. All prior Ordinances inconsistent with the language hereinabove are hereby repealed.
3. This Ordinance shall take effect upon passage and publication as required by law.
