3. This Ordinance shall take effect upon passage and publication as required by law.

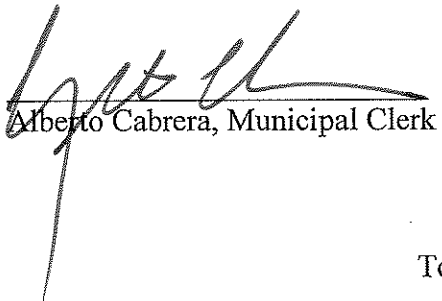

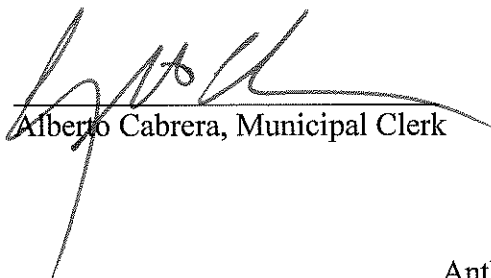

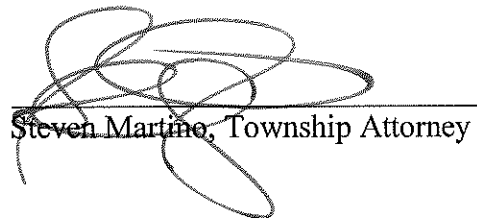
