The Township of Sandyston received your Open Public Records Act (OPRA) request via email on Tuesday, January 8, 2019. The official Records Custodian, Amanda F. Lobban, received your OPRA request on that same date. As such, the seven (7) business day deadline to respond to your request is Thursday, January 17, 2019. This response to your request is being provided to you on the first business day after the custodian's receipt of said request.

The records you request are as follows:

Please be advised, no documents exist relative to your request.

At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.

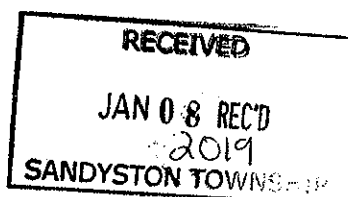
